This luncheon meeting will be an open discussion on multiple e-commerce topics raised by attendees. Bring your concerns, questions, and your soapbox, and be prepared to participate. Several topics have already been posed for this meeting, including:

- \* Is online banking from your phone or computer really secure? How is security achieved?
- \* Is your email load increasing – especially with huge attachments? How can these large files be handled?

#### DRIVING DIRECTIONS TO THE TAIX FRENCH RESTAURANT:

The restaurant lies north of downtown Los Angeles, in the Echo Park District near Dodger Stadium, on Sunset Blvd. near the intersection with No. Alvarado St.

#### FROM THE NORTH:

- Take the 101 (Hollywood) Freeway south toward Los Angeles.
- Exit from the 101 at Alvarado St.
- From the off-ramp, turn left onto Alvarado and proceed about a half-mile to Sunset Blvd.

#### FROM THE SOUTH

- Take the Santa Ana (I-5) freeway northbound and transition to the 101 Freeway northbound before reaching downtown. Continue on the 101 Freeway northbound through downtown.
- Exit from the 101 at Alvarado St.
- From the off-ramp, turn right onto Alvarado and proceed about a half-mile to Sunset Blvd.

#### FROM PALOS VERDES & BEACH CITIES

- Take the 110 Freeway north toward Los Angeles.
- Just past downtown, transition to the 101 Freeway northbound toward Hollywood.
- Exit from the 101 at Alvarado St.
- From the off-ramp, turn right onto Alvarado and proceed about a half-mile to Sunset Blvd.
- Exit from the 101 at Alvarado St.
- From the off-ramp, turn right onto Alvarado and proceed about a half-mile to Sunset Blvd.

#### FROM THE WESTSIDE

- Take the I-10 Freeway east toward Los Angeles.
- Approaching downtown, transition to the 110 Freeway northbound toward Pasadena.
- After passing downtown L.A., transition to the 101 Freeway northbound toward Hollywood.
- Exit from the 101 at Alvarado St.
- From the off-ramp, turn right onto Alvarado and proceed about a half-mile to Sunset Blvd.

#### FROM POINTS EAST OF DOWNTOWN:

- Take your favorite freeway (#110, I-10, #60) toward Downtown Los Angeles.
- Before reaching downtown, transition to the 101 Freeway northbound toward Hollywood.
- Exit from the 101 at Alvarado St.
- From the off-ramp, turn right onto Alvarado and proceed about a half-mile to Sunset Blvd.

#### ALL:

- Turn right onto Sunset Blvd. and find TAIX on the left side of the street at the first traffic light, about 200 yards down Sunset.
- Enter the TAIX parking lot and take a valet parking ticket for validation inside.
