DRIVING DIRECTIONS TO EDWARD'S STEAK HOUSE, EL MONTE

Edward's Steak House is located along the roadway that is adjacent and parallel to the I-10/San Bernardino Freeway, on the south side of the I-10.

FROM DOWNTOWN AREA OF LOS ANGELES

- Take the I-10 Freeway eastbound from downtown, and exit from the I-10 at Baldwin Blvd.
- Follow the exit ramp around a 180-degree bend to where it connects with Flair Drive.
- Follow Flair Drive westward to the restaurant at the corner of Fletcher Avenue. Parking is to the rear of the building.

FROM THE 710 FREEWAY NORTHBOUND

- Take the 710/Long Beach Freeway north to the I-10/San Bernardino Freeway.
- Go EAST on the I-10 Freeway, then follow the driving instructions above.

FROM I-10 FREEWAY WESTBOUND

- Take the I-10 Freeway westbound and exit at Rosemead Blvd-SOUTH.
- Take Rosemead Blvd. South, go under the I-10 Freeway, and turn left onto Telstar, then immediately another left onto Flair Drive.
- Follow Flair Drive eastward to the restaurant at Fletcher Avenue. Parking is to the rear of the building.
